## ELECTIONS!

The City of Cockburn has an elected Mayor and Council. Stephen Lee has become the City's first directly elected mayor. "This city is going places," said Mayor Lee, "I'm excited to reacquaint myself with the staff...there is no doubt we can be a successful team." Mayor Lee thanked his supporters and the members of his campaign team. "I will adopt a policy of having an open door and an open phone line," Mayor Lee informed the crowd assembled at the Civic Centre on election night.



It was a historic night on Wednesday December 6 as the first postal vote was held in the City. With 43.4% of ballots being returned the result was considered a good one by Council staff. "I think it was a positive return," said CEO Rod Brown.

Returning Officer Ken Bird said it was a close count. In the end Stephen Lee won by 154 votes over the next closest candidate Mary Jenkins. Because of the close count, the bundles of ballots were rechecked, however it was determined there was no need for a recount.



Stephen Lee was also a candidate for Central Ward Councillor, but his election to Mayor meant he could not be a Councillor as well. Thus the remaining three Central Ward candidates automatically became Councillors. They are Val Oliver, Martin Reeve-Fowkes and Nola Waters. In the East Ward Ian Whitfield, Richard Graham and Susan Rennie were elected to Council. Alistair Edwards, Laurie Humphreys, and Kevin Allen were elected to represent the West Ward on Council.

The Mayor's term will last until 7 May 2005. Councillors serve two or four year terms.

## LOCAL AGENDA 21

### Sustainability - What Council is doing?

Last month's article outlined some things that can be done around the home in the name of sustainability. This month we take a look at some of the things the Council is doing.

### Cities for Climate Protection (CCP)

CCP is a campaign of the International Council for Local Environmental Initiatives with over 370 local governments worldwide (the City of Cockburn being one) participating. CCP empowers local governments to cut greenhouse gas emissions. CCP is based on a structured, 5 level milestone, program. The City of Cockburn has completed milestone 2 and is currently working on milestone 3.

To date the City of Cockburn has conducted a greenhouse gas emission inventory and in December 1999 the City of Cockburn made the commitment for its 2010 greenhouse gas emissions to be 20% less than its 1995 greenhouse gas emission levels.

The City of Cockburn is now in the process of developing a Local Action Plan. Work undertaking to reduce our greenhouse gas emissions has included installing solar powered lights at Catherine point and Rotary lookout, the purchase of two dual fuel vehicles for the vehicle fleet and retro-fitting the Civic Centre by replacing incandescent lights with florescent lights.

### Environmental Management Systems (EMS)

EMS is a systems approach to improving environmental protection by using a single environmental management system across all functions of the organisation. EMS is a tool, which allows the Council to integrate environmental responsibilities into Councils corporate planning and management, and provides for continual improvement in environmental performance.

EMS contains the following elements:

- An environmental policy
- Identification of environmental aspects and significant impacts
- Identification of legal and other requirements
- Goals, objectives and targets that support the policy
- An environmental management program
- Definition of roles, responsibilities, and authorities
- Training and awareness procedures
- Process for communication of the EMS
- Document and operational control procedures
- Procedures for emergency response
- Procedures for monitoring significant impacts
- Procedures to correct non conformance
- Record management procedures
- Auditing program
- Procedures for management review.

The City of Cockburn is currently developing an environmental aspects and impacts register.

The City of Cockburn is committed to revegetation and weed control within a number of conservation reserves. In 1999/2000 \$52,000 was spent on revegetation and \$99,000 for weed management.

The City of Cockburn in conjunction with Melville, Canning, Fremantle and East Fremantle Councils finalised a deal with Bedminster (Australia) that will mean the contents of your rubbish bin will become compost rather than going to the tip. This will result in significant reduction in landfill gas emissions over the next 20 years.

The City of Cockburn is currently undertaking many activities that fall under the banner of sustainable development and the development of the Local Agenda 21 plan will ensure this continues.

## Draft Coastal Work Plan

What do the reserves, Coogee Beach, North Coogee and Manning Park have in common? They are part of the City of Cockburn's coastline, which are included in the Draft Coastal Works Plan.

The City of Cockburn and Comnet, with the assistance of Natural Heritage Funding, have developed a Coastal Works Plan. The Draft Coastal Works Plan has been developed in conjunction with the community, and outlines proposed works and environmental management for coastal areas.

The Coastal Works Plan can be viewed at the City of Cockburn Council Offices, Spearwood Library and Coolbellup Library, with summaries available at the City of Cockburn.

## DRAFT ISSUES PAPER

As part of its ongoing Local Agenda 21 project, the City of Cockburn and BSD Consultants held four targeted community meetings on 29th and 30th November to set the community's vision for the future of the City. A wide range of community groups were invited to attend, including resident's associations, environmental groups, community groups such as Lions and RSL, business representatives and sporting groups. Those unable to attend were sent information about the project, and invited to submit comments to the City. Such information packages were also sent to schools in the City, to encourage their participation.

The meetings were a huge success, demonstrating that the community is, in general, highly conscious of the current scenario in Cockburn, and has a strong idea of what they want the City of Cockburn to become in the future. Although issues that some people saw as weaknesses these were also perceived as strengths by others (eg industrial development), and some issues perceived as threats were perceived as opportunities by others. On the whole all participants strongly supported the Local Agenda 21 process, and agreed that good planning and good community consultation would go a long way to helping Cockburn develop to its maximum potential.

### SWOT Analysis

A significant proportion of the sessions was spent conducting Strengths Weaknesses Opportunities and Threats analysis of the City. As can be seen below, the community believe that the City of Cockburn has excellent potential to develop into a model community, with a vibrant urban centre, positive community attitude, and high environmental standards.

### STRENGTHS

- Natural Assets (Coastline, Wetlands, Bushland).
- Size of the City.
- Ethnic diversity/diversity of population and interests.
- Education values ("open classroom") of natural/cultural areas.
- Social connectivity with natural assets.
- Strong community groups.
- Coastal Location.
- Access to regional transport systems.
- Proximity to high quality international Universities (Murdoch and Notre Dame).
- Strong retail centres.
- Good support from the City of Cockburn.
- State Government is willing to invest significant amounts of money into Cockburn based development.

### WEAKNESSES

- Cockburn, and especially its coastline, is dominated by industry.
- Cockburn has "no soul", and "no heart" and is visually unattractive.
- Lack of town centre/social values.
- No economic development strategy.
- Poor planning in terms of the interface between environment and urban areas.
- Low sense of security/safety.
- Low value, both internally and externally perceived, creating a dumping ground with a lack of community pride and esteem.
- Highly fragmented society, geographically and in terms of facilities.
- All transport, both roads and public, is oriented north-south, or to and from Fremantle and Perth. There is no intra Cockburn transport network, and public transport is generally poor.
- Natural assets are being degraded at a high/unacceptable rate.
- Inadequacy of state legislation and concern for Cockburn, and a lack of community control of State planning issues.
- No give/take relationship with State Government ("State takes, takes, takes").
- High cost to community when natural capital is misused/given the inappropriate economic value.
- No faith in the DEP/EPA to protect environment.

### OPPORTUNITIES

- Build on current diversity of interests.
- Natural assets, and potential for eco-tourism, education, and simply as a natural asset. These assets do not occur anywhere else in the world (eg Beeliar Wetlands).
- Size of the city, with growth opportunities.
- Appropriate use of freeway, if combined with rail/public transport to the coast.
- Building conditions for future developments, such as passive solar design standards, and requirements for visual amenity.
- Community input for setting industry standards.
- Horticultural options.
- Big business/small business connections and development.
- Much of Cockburn is a blank canvass, with good opportunity for high standards of sustainable community design.
- High-level of community interest and knowledge.
- Creating an industry based on environmental values and state of the art technology.

### THREATS

- Impression that Perth needs more industrial land, and Cockburn is the ideal location.
- State Planning Commission, and a lack of understanding of what the people of Cockburn want.
- Roe Highway, Fremantle-Rockingham Controlled Access Highway, and roads in general.
- EPA and DEP do not have community interests at the forefront, and are overshadowed by other department's decisions.
- Decisions are made from the outside, with no real idea of the impacts.
- State Government departments suffering from "Capture Theory".
- Residents that oppose ALL development.
- Lack of communication between residents and developers.
- Non cooperative councillors and council staff.
- Bad reputation.
- More bad planning.

From this analysis, a vision for the future of Cockburn was sought. The common themes of this vision can be summarised as follows:

In 30 years time our vision for Cockburn is a community that:

- Is less wasteful, treats waste as a resource, minimises waste.
- Has a vibrant heart, is attractive, has a good energy, and a self empowered community.
- Retains, values, utilises and appreciates its environmental assets.
- Appropriately considers environmental and community values in decision making.
- Has the ear of all levels of government.
- Has community based, efficient public transport that serves the needs of the Cockburn community.
- Is aware of its environment, and encourages sustainable practices in the community, such as recycling, gardening, energy and product use etc.
- Is a safe and secure place to live.
- Offers good quality education opportunities, utilising the natural and social resources available.
- Is amongst Perth's leading environmental managers.
- Has well planned beach areas meeting environmental and social needs.
- Contains pollution free/clean industrial developments.
- Houses world class industrial developments, and fosters the co-location of related small business.
- Is a show case of environmental and pollution reduction industries.

# Vanishing Wildlife

It is not only the plants in our conservation reserves that make them a pleasing place to visit but it is also the many animals and birds that can be seen. We endeavour to encourage wildlife in our reserves with one of our aims being to maintain reserves in a condition that provides much needed habitat for our unique wildlife. But no matter how much we work at maintaining these areas there are always problems with which we require the community's help.

One such problem was brought to our attention by a number of concerned citizens who noticed that young swans (cygnets) appear to be missing from around a number of the wetlands. The cygnets still had the plumage associated with young swans and had not yet developed feathers to allow them to fly. They could be seen swimming, walking or sitting with their parents and appeared to be thriving. It is possible that they may have been taken by predators such as foxes or even cats but there is also a rumour that they may also have been removed by persons or people for reasons known only to them.

The taking of wildlife is an offence under the Wildlife Protection Act and the Wildlife Conservation Act. Heavy penalties apply to anyone convicted of taking wildlife without a permit or appropriate authorisation. # PROBLEMS WITH RETAINING WALLS?

Landowners and new homebuilders are often unexpectedly faced with having to install a retaining wall. This can be an expensive and complicated problem, which often causes ill feelings between neighbours.

Council has seen the need to have a policy, which outlines the rights and responsibilities of landowners placed in this situation. It is often not known that a person must obtain a Building Licence from Council before work can commence. This is to ensure that walls are properly designed and will be structurally stable.

There are limits on how high a retaining wall can be built and there are responsibilities for those carrying out the work not to destabilise existing buildings in the vicinity.

The Policy also contains information on party walls, rights of adjoining neighbours and how disputes may be resolved and is available at Council's Administration Offices during normal business hours.

# Turn Cockburn upside down to find the next Australian of the Year and Community of the Year

Council is calling on the people of Cockburn to turn the district upside down to find Cockburn's 2001 Citizen, Young Citizen of the Year and Community of the Year.

The Citizen of the Year Award recognises an individual who has made an outstanding contribution to this community. The Young Citizen of the Year Award recognises similar achievements by young people up to 25 years of age.

The Community of the Year Award recognises the achievements of an entire community or group, such as a specific community project, the work of a particular group or organisation or a record of achievement by a suburb or area.
